Change cartridges according to cartridge specifications.

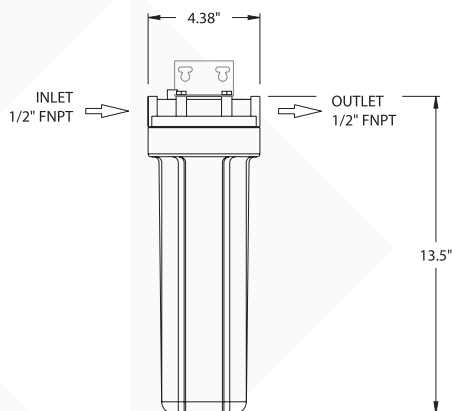
