### INSTALLATION TIPS

Install vertically so cartridge hangs down. Allow 2-1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.

Flush cartridge by running water through system for five (5) minutes at full flow.

### OPERATION TIPS

Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar).

It is recommended to replace cartridge at least once per year.

Always flush the filter cartridge at time of installation and cartridge change.

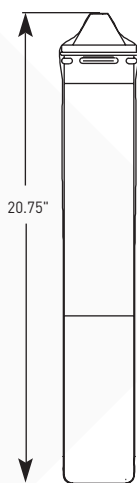
